Re: Censorship on Government Facebook and Twitter Pages

Dear Senator Albers:

Our democracy thrives when people can freely criticize elected officials—including yourself—so that the people you answer to can best determine whether you should remain in office. The American Civil Liberties Union of Georgia (ACLU-GA) writes on behalf of nine Georgia residents, Daryl O’Hare, Angie Jones, Tamara and Matt Stevens, Elizabeth Goldsmith, Jeanie Shiau, Francene Taylor, Nancy Miller, and Susan Gue,<sup>1</sup> who have been blocked from posting on, or even viewing, your official government Facebook page ([www.facebook.com/john.albers](http://www.facebook.com/john.albers)) or Twitter page (@johnalbers), which are otherwise open for public comment or at least to preselected “Friends.”<sup>2</sup>

It is our understanding that you had previously created a separate government Facebook page<sup>3</sup> titled “Senator Albers,” which used the address [www.facebook.com/senatorialbers](http://www.facebook.com/senatorialbers), and which was one time used to stage town hall meetings. *See* Exhibit H (screenshots taken by Ms. O’Hare). It appears that you have since deleted that page, and that your default account page now operates as your official government page at [www.facebook.com/johnalbers](http://www.facebook.com/johnalbers), to which you now direct your constituents. *See* Exhibit I. That default Facebook page is emblazoned with the

banner “Senator John Albers, GA District 56,” publicizes your official government website [www.senatoralbers.com](http://www.senatoralbers.com), *see* Exhibit J, and is predominantly used to publicize official government business.

Thus, whether you intended to or not, your Facebook default account page now functions practically as an official government page. And because your government Facebook and Twitter pages have been opened for some members of the public to post comments, it is considered a “limited public forum.” *See Perry Educ. Ass’n v. Perry Local Educators’ Ass’n*, 460 U.S. 37 (1983). And when a limited public forum has been created, it is unconstitutional for the government to discriminate against certain speakers because of the viewpoints they express. *See Rosenberger v. Rector & Visitors of Univ. of Virginia*, 515 U.S. 819, 829 (1995). Though legal challenges to censorship on government social media sites are a relatively new phenomenon, at least one court has already found that targeted censorship on government Facebook pages open for public comment is unconstitutional. *See Davison v. Loudon County*, 2016 WL 4801617 (E.D. Va. Sept. 14, 2016) and 2017 WL 58294 (E.D. Va. Jan. 4, 2017). And just last week, Maryland Governor Larry Hogan settled a federal ACLU lawsuit over this issue by agreeing to pay \$65,000 to the plaintiffs and to rewrite his social media policies to conform to the Constitution.<sup>4</sup>

Regardless of the reason you deleted your previous government Facebook page, no government official can escape the requirements of the First Amendment by masquerading their actual government Facebook page as a “personal” page, and then by curating the contents of that page to ensure that it is filled only with glowing praise. A reasonable observer might believe, rightly or wrongly, that this is what your office has done.

Of course, you yourself have the First Amendment right to create your own personal or campaign Facebook page, in which you have the right to curate or delete comments or block individuals with whom you disagree. For that reason, we strongly recommend that you return to your prior practice of having two separate social media pages: one personal, and one for government business, for both Twitter and Facebook, and segregate your posts accordingly, as other elected officials like Congressman Barry Loudermilk have done.<sup>5</sup> Although this is a burden that other members of the public do not have to carry, it is a light burden that comes with the privilege of serving in public office.

As social media becomes more integral to the political process and public discourse, government officials must not engage in any form of viewpoint censorship in violation of the First Amendment. As the Supreme Court of the United States has recently said, “[i]t is cyberspace—the ‘vast democratic forums of the Internet’ in general, and social media in particular,” that is “the most important place[] . . . for the exchange of views” in the modern era. *Packingham v. North Carolina*, 137 S. Ct. 1730, 1735 (2017).

We respectfully ask that you restore the posting privileges of the individuals identified above<sup>6</sup> or provide a legal justification for why they have been blocked, undertake a review of all people whose posting privileges have been censored, and restore all of those who have been unlawfully blocked for commenting. To unblock someone on Facebook, click the question mark on the top blue bar of your Facebook page, click “Privacy Checkup,” click “Privacy Shortcuts,” click “How do I stop someone from bothering me?,” click “View All Blocked Users,” then click “Unblock” next to the name of the person you wish to unblock. To unblock someone on Twitter, click the circular self-portrait to the right of the “Search Twitter” bar, click “Settings and privacy,” click “Blocked accounts,” and unblock the appropriate persons.

We would greatly appreciate it if you could notify us within 30 days your response to the above requests. If you would like to discuss a social media policy that comports with the First Amendment, we are also happy to discuss that option with your office by phone. We look forward to hearing from you.
