Good morning Sheriff Smith:

This is Edward Ahmed Mitchell, attorney and executive director of CAIR Georgia. I sent you an email last week about Mr. David Bores' upcoming "Islam in America" presentation, but my message may not have reached you because I attached a large PDF file to it. I am resending the message now without the attachment.

Let me first thank you for your service to Barrow County. As a former criminal prosecutor, I have great respect for the work that you and your deputies undoubtedly perform on a daily basis to protect local residents of all faiths and backgrounds.

I write because the family member of an anonymous Georgia law enforcement officer recently contacted CAIR Georgia to let us know that Mr. David Bores is scheduled to deliver a presentation titled "Islam in America" to your office on March 8th.

<u>Please click here to download a PDF file</u> with a letter outlining our own concerns about Mr. Bores' anti-Muslim teachings, as well as his lack of subject-matter expertise. The file also contains a detailed report that documents the false and defamatory claims Mr. Bores has made in past presentations about Muslims, Jews, and others.

Among other things, Mr. Bores has previously taught audiences that:

- "Remeber that 80 percent of the mosques in this country preach violence."
- A mosque is an "armory" undeserving of First Amendment protection
- "[The] First Amendment shelters all of Islam and it should not."
- American Muslims are part of a global Muslim Brotherhood conspiracy to somehow impose "Sharia" upon our nation.
- Muslim student groups at "the University of Georgia, Georgia Tech, Georgia State, and Georgia Southern University" are part of that fictional conspiracy.
- Islam allows Muslim men to molest male children: "Little boys don't wear beards. That means they can be molested. They're toys. They're sex toys."
- "Islam regards the female body essentially as evil and the cause of sexual immorality."
- "The number of mosques that have risen in our country since 9/11 virtually has doubled.
 We have some 58 in Georgia. All of this represents sedition under Title 18 United States Code."

Mr. Bores has also targeted people other than Muslims during his presentations. He has said that former President Barack Obama somehow "embraced Islam," claimed that Georgia House Speaker David Ralston "supports Sharia law in Georgia courts," and implied that German Jews were partly to blame for the Holocaust.

<u>The downloadable file contains digital hyperlinks</u> to these and other time-stamped quotes, as well as video and audio files of speeches containing those quotes. We have previously shared this report with the P.O.S.T., which is currently investigating the matter.
