Re: Illegal Election Day polling place hours in DeKalb and Fulton Counties for the City of Atlanta general election

Dear DeKalb and Fulton County Boards of Registration & Elections and Secretary Kemp,

It has come to our attention that both the DeKalb and Fulton County Boards of Registration & Elections have publicized Election Day polling place hours for the City of Atlanta to be from 7 a.m. to 7 p.m. on the My Voter Page (www.mvp.sos.ga.gov) for individual Atlanta voters. *See* Exhibit A (my voter page for Atlanta voter living in DeKalb County); Exhibit B (my voter page for Atlanta voter living in Fulton County).¹ (We were unable to locate any other public website on either of your webpages publicizing Election Day hours at all.)

Closing Atlanta polling places at 7 p.m. on Election Day is illegal. State law requires that polling places for the city of Atlanta be open from 7 a.m. to 8 p.m. on Election Day, which helps to ensure that Atlanta citizens who work late and must struggle to beat Atlanta traffic can exercise their sacred and fundamental right to vote. According to O.C.G.A. § 21-2-403, “[a]t all primaries and elections the polls shall be opened at 7:00 A.M. . . . and shall remain open continuously until 7:00 P.M., . . . *provided, however, that, in all cities having a population of 300,000 or more . . . , the polls shall remain open continuously until 8:00 P.M. . . . during the*

¹ Several weeks ago, DeKalb County had informed us that its polls would remain open until 8 p.m., though a follow-up telephone conversation yesterday indicated the hours would end at 7 p.m. We also learned telephonically yesterday that Fulton County Election Day hours would extend until 8 p.m. In light of these conflicting indications and the illegal or erroneous hours posted publicly for Atlanta voters, we are submitting this letter publicly to expeditiously resolve any ambiguity before voter confusion gets any worse.

cities' general elections.” (emphasis added). Because of the size of its population, the City of Atlanta qualifies for the 8 p.m. extension, and thus, the DeKalb and Fulton County polling places that are also located in Atlanta must be open until 8 p.m. on Election Day.²

Please confirm within 48 hours that that DeKalb and Fulton County polling place hours on Election Day will comply with state law and be open from 7 a.m. to 8 p.m. for the City of Atlanta, and explain how you intend to publicize those legally required hours to ensure that all impacted citizens are properly notified in a timely manner—not just on the My Voter Page for individual voters but publicly as well. Otherwise, we reserve the right to bring legal action.

We have also included the Secretary of State's Office in this correspondence to the extent that control of the My Voter Page is in the hands of the Secretary of State. Regardless of who has control over the webpage, both the Secretary of State and the county Boards of Registration & Elections are responsible to the voters.

Lastly, we observe that both DeKalb and Fulton Counties have different hours for the City of Atlanta during the early voting period, and that Fulton County's early voting hours include both evening and Sunday hours, which more realistically reflect voters' needs. *See* Exhibits C, D. We strongly urge DeKalb County to follow Fulton County's lead in this regard to ensure that all Atlanta citizens are treated equally, and we are happy to discuss this matter further for future elections.

Our democracy is healthier when more voters participate, not fewer. We look forward to hearing from you.
